REGISTRATION AND CANCELLATION POLICY

The present terms and conditions apply to The World Demolition Summit 2011 incorporating the World Demolition Awards and World Demolition Conference, taking place on 1 November 2012 at the NH Grand Hotel Krasnapolsky in Amsterdam (The Netherlands).

1. HOW TO BOOK

Participants can buy places at the World Demolition Summit 2012 at www.demolitionsummit.com. Payment is made by bank transfer or by credit card (Visa, MasterCard or American Express) as part of the registration process. No registration is effective until payment has been received and processed successfully.

Fees paid by participants cover, as appropriate, admission to the World Demolition Awards 2012 gala dinner and/or the World Demolition Conference 2012 and all the Summit's conference sessions, lunch and coffee breaks during the conference. All prices are subject to Dutch VAT where applicable.

2. CONFIRMATION OF REGISTRATION

An email confirmation of registration/acknowledgement of payment will be sent to each registrant upon receipt of payment together with an invoice. Delegates are asked to bring a copy of the confirmation.

3. CHANGES OF PARTICIPANT

Organisations/companies who have purchased places can change names of participants until 1 October, 2011, free of charge.

4. CANCELLATION POLICY - CANCELLATION BY THE PARTICIPANT

Participants can cancel their registrations until 3 September 2011. Until that date, payments received by KHL will be refunded (limited to the amount paid by the participants), minus a fee of €50 to cover administrative and banking costs. Refunds will be handled after the event.

In case of cancellation after 3 September 2011 or in case of no-show, no refunds will be made.

5. CANCELLATION POLICY - CANCELLATION BY THE ORGANISER

If the organiser cancels the event for any reason other than force majeure, registration fees are refunded to registered participants. However, refunds are limited to the amount paid by the participants. The organiser is not liable for any other loss or expenses incurred by participants as a consequence of the cancellation.

In the event that the World Demolition Summit 2012 would be cancelled, postponed or relocated on account of fire, flood, riot, earthquake, civil commotion, decisions taken by the national and/or local authorities, weather conditions, strike, lock-out, labour disturbances, explosions, sabotage, accident, terrorism, war, acts of God or any other causes or casualties beyond the control of the organiser, no refund shall be made. Participants to the Demolition Summit 2011 waive all claims for damages in this case.
